Program Reports - Richelle & Jo-Anne

- The 3rd old program, Learn to Skate, Pre-Hockey, CanSkate, SSJ and Pre-Power and Prelim Prep programs were all a tremendous success again this year. All of our programs were full once again and ran smoothly. I have to say that the Pre-Power program showed the biggest growth with 28 skaters participating on Mondays and 26 on Wednesday, amazing! Also, the Prelim Prep program had 16 skaters by the end of the season, which was a record for this program!
- Star Skate & Competitive went extremely well this year. We had some fantastic test days, the girls represented our club very well at all competitions this year. Most brought home medals and if they didn't, they always did their best.

<u>Treasure Report</u> - Terry Thomas

Camp Revenue - made more in summer school this year than the previous year. Spring school was not subsidized this year.

Music Revenue - was handled through the club credit account this year

Off Ice/Dance Revenue - resulted due to a credit from Star Baton for space previously rented

Skating Program Revenue - more skaters, more days, fees were up this year to cover increased costs

Interest Revenue - from GIC cashed in

Wages - increase due to only 1 month of Administrators salary on last years statement Coaching Fees - wages went up, more skating days

Insurance - posted to the incorrect account last year, corrected this year

Chargebacks - are being posted through the Skating Programs this year

Ice Fees - bulk of the 2006-2007 Ice fees had not been paid until April last year as the Invoices needed to be reconciled first

Skating Programs - NSF Charges are posted to this account, Skate Canada fee increased and there were more refunds

Meals & Entertainment - Executive didn't have a Team Building event last year, this year it includes Stage West at the end of April

Test Achievements - Donna Hlushak

This 2007-2008 skating season the ASC was very busy. From May 2007 - March 2008 we hosted 5 Skate Canada STARSkate test days. We totaled 120 just for the ASC skater tests which almost doubled from 68 tests last year. The accomplishments achieved this year were outstanding and surpass any other in the some 30 years of the Airdrie Skating Club. This year we recognized 51 Skate Canada STARSkate Certificates. We recognized 5 skaters who achieved 7 Gold Skate Canada STARSkate Certificates.

Competition

- This years 'Airdrie's Winter Wonderland Competition was a huge success. Because we had the two events running, Calgary Region Funskate and the STARSkate South Runoffs at the same time, we were provided with two of the most fun loving, dedicated Ice Tech Reps a club could ever ask for. Their love of the sport made our success even greater by having their knowledge at hand.
- With over 700 entries & over 800 volunteer hours, the club profited \$13,594.64 which will be used to help off-set the ice fees next year
- Volunteers who volunteered their time over and above their commitment will be allotted credits based on the hours worked
