Ice Schedule

- JoAnne states that all clubs struggle with ice times
- Use of more off ice programs helpful
- Off-ice program to Start at Prelim Prep level, showing the skaters in that level what to inspire to.
- Use available space such as dressing room
- Purchase a carpet that can be placed over the dirty floor
- Off-ice would help with the amount of skaters on the ice and fees would be comparable
- JoAnne talked to Richelle about getting the Prelim Prep skaters to use more of the ice surface, not just certain areas

Information programs

- Someone to work with the Coaches to bring outside sessions for the skaters
- Sessions on Nutrition, Drama, Dance, Faith Woods etc.
- Building blocks to help skaters advance
- Discussed including the fees in registration fees or offer to the skaters and they would be responsible for it themselves

Morning Ice

 - Requested that Chelsea be asked if she would be willing, but will the skaters work for her?

Ice Times

 JoAnne has worked on the ice times and will forward to Terry M to send to the City

- Friday ice to move 15 minutes later, from 1:45 to 2:15 and Star skate session 2:30 to 5:45
- Christmas Solo Show, moved to Dec 19, 6-7:30 so that more parents can attend
- Move Gala to the very end of March. No more skating until Spring school
- LTS-Canskate to start after Thanksgiving until Dec 17. Start later, end later and then 2 week break to match school system. Next session to start Jan 5-Mar 11.
- Spring school to start May 4 June 12, therefore all of April off and not such a long break for skaters not attending Summer school.
- Wants Sunday ice for Pre-school session
- Changes to StarSkate sessions. Last years program did not work as well
 as thought. Ice times open to any Starskaters based on level. Looking at
 breaking groups into StarSkate Jr, Int., and Sr groups.
- Coaches want to work as a team. JoAnne has talked to Lynell about not showing up on time.
- Lynell will be doing Dartfish, program has been purchased. Skaters will be billed out from the Coaches for Dartfish, $\frac{1}{2}$ hour once a month for skaters. Coaches to use as teaching tool.
- Power skating- would like to offer in September at twin arena. Donna to check into availability.
