Financial Reports

- Financial reports are up to January 31, 2008
- Comparatives are almost the same as last year with a few exceptions
 - Camp revenue is up
 - Advertising expenses are up
 - Insurance expenses are up due to the previous year, the posting wasn't in the right account
 - Ice fees are such a difference because last year at the same time, ice fees were not paid as yet
 - Music and PA fees, last year we didn't have the account as we do now after the accountant created it
- Currently we will still have ice fees up to the end of March of roughly \$14,000
- not much income at this point, not so much expenses as well.
 - Spring school will pay for itself
- Retained earnings are about \$91,000 right now.
 - we really should be thinking about donating some money to the $3^{\rm rd}$ phase of the East Lake Wellness Centre
 - the \$7000 hockey has already donated does not include the \$25/registration that they are also donating from each registered skater

- when we donate, we need to make sure all opportunity is used to make sure it's also in the papers; perhaps donate closer to August, closer to our registration time
- perhaps donate some money to the Alberta skating fund
